THIS DEED OF TRUST is made on 27th day of February, 2015 at Bareilly.





- 6. Mr. Shuja Khan shall be the first Managing Trustee/Chairman Of Board of Trustee and he will manage the Trust affairs and the institutions to be set up pursuant to the stipulations of this deed and after him the Managing Trustee for the Trust and management of institutions to be set up shall be by majority votes of the existing members.
- 7. All the Trustees together be called as Board of Trustees headed by the Chairman to be elected once in every two years amongst the Trustees. The office of the Chairman shall be for a period of two years. Any question arising in the administration of the Trust shall be decided by a vote of the majority of the Trustees as are present and vote at a duly convened meeting, and the Chairman of the meeting shall have casting vote in case of equal votes. The Chairman may also take administrative decisions which have to be ratified in the subsequent meeting. A resolution may also be passed by circulation. The Trustees will be Honorary and



- v) To establish, maintain and run students, scholarships and render other kind of aid to students with special emphasis on Muslims, including supply of books, stipends, medals and other incentives to study.

- xiii) To conduct/operate programmes for providing nutritional assistance e.g. to operate a school/lunch/food programme for children, operate




nutritional supplement programme for needy women which shall be provided/conducted/distributed free of charge.

- xiv) Testing of diets from nutritional point of view.
- xv) To render assistance to poor patients by providing medicines etc., provisions of health care, preventive medical services (including dental services).
- Assistance to hospitals in setting up the various facilities such as Blood Bank, Eye Bank, Burn Centres etc. For the poor patients.
- xvii) Provisions of the outdoor dispensary or assistance thereof and also to run "Mobile" medical services.
- xviii) Conduct education in health care or provide assistance in provisions of primary healthcare education.
- xix) To render assistance to the handicapped.
- xx) To provide monetary assistance and social services in case of natural calamities.
- xxi) To render financial assistance to the poor and the disadvantaged.
- xxii) To promote and advance moral education, charity and general welfare of the people.


Playground and part and other social welfare works and / or activities for public use.

- To meet travelling, boarding and lodging expenses of students going abroad for higher, Engineering, Technical, Medical Management or other professional education.
- To organize seminars, symposia and the like for intellectual simulation and spreading message of the Contemporary thinkers, philosophers, social workers, scientist & economists.
- MXXIII) Holding of medical relief camps, such as eye camps for general medical check-up, vaccinations and for check up of the other disease.
- xxxiv) To acquire and maintain ambulance service.
- To provide material help such as wheel chair, artificial limbs etc to handicapped, disabled and infirm persons.
- 11. The trustees shall have all powers as may be required for the proper conduct of the affairs of the Trust. The Trustees shall have the power to initiate prosecutions and defend legal proceedings as may be reasonable and proper for safeguarding the assets and properties of the Trust as also the Trust funds and interest. Any action taken by such Trustees in this regard shall be deemed to have been taken and ratified by all Trustees.

Powers and Duties of Trustees:

The management and administration of Trust properties shall vest in the following


- (i) Chairman
- (ii) Secretary
- (iii) Treasurer
- (iv) Remaining Members.
- 12. The Trustees may open an account(s) with any Bank(s) in the name of the Trust to be operated upon by any one Trustee jointly or separately or the authorised representative of the Trust on behalf of the Trust.
- 13. The surplus funds of the Trust which has not been spent in any year shall be invested in the modes prescribed under relevant sections of the income Tax Act 1961, as amended from time to time.



- 14. The Trustees shall at their discretion, acquire, purchase or sell immovable or immovable properties in the course of managing of Trust. However, any sale of Trustees.

 Trustees.
 - 15. No income of the Trust shall be applied for the personal benefit either of the Trustees or of the Settior.
 - 16. In the event of dissolution or winding up of the Trust, the assets remaining as on the date of dissolution shall under no circumstances be distributed among the Trustees/Members of the Managing Committees/Members of the Governing Body, but the same shall be transferred to another Charitable Trust, Society, Association or Institution whose object are similar to those of this Trust and which enjoys recognition under relevant section of the Income Tax Act, 1961.
 - 17. No amendment of the terms of this deed shall be made without obtaining the prior written permission of the Commissioner of Income-Tax. However, the amendments to be carried out shall not infringe the provisions of the Income Tax Act, 1961.
 - 18. The objects of the Trust shall be achieved without involving any activity for profit.
 - 19. The Trustees and the members of their family shall not be entitled to the benefits of the Trust.
 - 20. The Trust formed is irrevocable.
 - 21. The funds/income of the Trust shall be solely utilised for achieving the objects of the Trust and no portion of it shall be utilised for the benefits of the Trustees by way of interest, bonus, dividend, profit, etc.

22. The benefits of the Trust shall be open to all Indians irrespective of the caste, creed or religion.



23. The accounts of the Trust shall be regularly maintained and audited by a Chartered Accountant every year. The accounting year for the Trust shall be from 1° April to 31° March each year.

24. Rules and Regulations:

The Board of Trustees shall have the power to make such rules and regulations for administering the Trust as it may deem and necessary by majority decision.

25. Delegation:

The Board of Trustees shall have the power to appoint any one or more of the Trustees to administer to specific projects, initiative or activities and to provide for any reasonable and fair remuneration.

26. Dealings with legal and Statutory Bodies:

The Chairman and Secretary shall have the power to deal with, file papers and documents, hold meetings and do all other necessary acts, deeds and things. This shall also include dealing with all State and Central Government Departments and Banks as may be necessary and expedient in the interest of Trust.

- 27. This is an independent trust and is not associated with any institutional body. There is no movable and immovable property in the name of Trust at present.
- 28. That in case of any dispute or difference arises in respect of terms and conditions of this deed or relating to this deed, then the same shall be referred to the Arbitrator appointed with consent of settlor or trustees whose decision shall be binding on the parties hereto and the decision of the Arbitrator shall not be question in any court of law. The proceedings before Arbitrator shall be conducted in accordance with the provisions of Arbitration and Conditiation Act, 1996.
